Entry:

- Entry can be completed online from 16 October 2021 to 21 October 2021
- This is a photographic competition and each entrant can submit up to five (5) images which should include at least one full length shot and a close-up of a chosen aspect of their outfit's details.
Note: Please ensure your images are high resolution
Images can be taken inside, outside or in both settings
It is at the entrant's discretion as to who takes their photos & optional video for them
Each entry must submit a minimum of one (1) - and no more than five (5) - images
- Entrants may also submit one (1) 15 sec video should they wish
- Contestants must be at least 18 years of age and residing in New Zealand
- Hawkes Bay Racing Incorporated reserves the right to ask for proof of age
